Legislature's Budget Plan Calls Housing the "Biggest Driver" of California's High Cost of Living, Restores Critical Funding for Affordable Housing but Neglects Essential Homelessness Resources

The Assembly and Senate released a [joint legislative budget plan](#) yesterday that restores funding for some of the state's most successful affordable housing programs — a critical step toward finalizing a state budget that offers much-needed support to lower-income Californians who are struggling to find a safe, affordable place to live.

Recognizing housing as "the biggest driver" of the state's high cost of living, the Legislature has proposed investments in two key programs our coalition has been advocating for: **\$500 million for the Low-Income Housing Tax Credit Program (LIHTC)** and **\$120 million for the Multifamily Housing Program (MHP)**.

However, we are deeply concerned to see that the Legislature's proposal does not include funding in this year's budget for the Homeless Housing Assistance and Prevention Program (HHAP), especially at a time when our local communities anticipate an end to the federal emergency housing voucher program, eliminating 15,000 vouchers for people experiencing homelessness. As homelessness has increased 18% nationally, HHAP has been instrumental in preventing significant increases in California. Despite this proven record of

success, this budget provides no HHAP funding to big cities, counties, and Continuums of Care (CoCs) in 2026. Without HHAP funding this year, CoCs and service providers across California will struggle to deliver essential services and housing opportunities in their communities. In some communities, HHAP is the primary source of funding to serve people experiencing homelessness. This choice will slow down our work to reduce the number of people living on the streets. We urge the Legislature to allocate at least \$500 million for HHAP in the 2025-26 budget.

We also urge the Legislature to allocate at least 50% of the \$300 million proposed for the California Dream for All program to CalHome. We commend the Legislature's support for homeownership, particularly creating more pathways to homeownership for low-income Californians. However, the dual goals of increasing new housing production and making homeownership available to first-time homebuyers would be better achieved by including an allocation to CalHome in the final budget, which funds the construction of new homes that offer a path to affordable homeownership to lower-income households.

Our statewide coalition of affordable housing, homelessness, and housing justice organizations applauds the Legislature for directing resources to LIHTC and MHP during a challenging budget cycle, and we ask that funding be provided to HHAP and CalHome so that we can continue progress on our state's goals to make housing more affordable and accessible to all Californians and to reduce homelessness. Now, more than ever, we need a budget that reflects the needs of our most vulnerable residents.

Legislature chose not to fund the Homeless Housing, Assistance and Prevention (HHAP) program this year as HHAP puts resources in the hands of the folks closest to the crisis as it is an important tool for Tribes who are unable to access most other state and federal programs and face some of the greatest challenges.”
